## **Terms & Conditions:**

As a condition of enrolling a participant in any course at Dreams Cricket Academy (DCA), you agree to accept these terms and conditions on behalf of the course participant. These terms and conditions may be amended from time to time without notice.

1. **Eligibility:** The academy is open to players aged 6 years and above, focusing on enhancing their cricket skills and general sports abilities.
2. **Attendance and Refunds:** If a child misses any sessions not due to DCA's fault, no refund will be issued. If sessions are missed due to DCA's fault, alternative sessions will be arranged, or a refund will be given.
3. **Insurance:** While DCA is fully insured, participants are encouraged to have their own private insurance cover for additional protection.
4. **Force Majeure:** DCA will not be held liable for any events beyond their control, such as natural disasters, strikes, or other unforeseen circumstances.
5. **Uniform Policy:** It is mandatory for all participants to wear the official DCA uniform during training, matches, and other activities. Participants not adhering to this policy may be turned away.
6. **Binding Agreement:** This agreement shall be binding upon and inure to the benefit of the parties, their successors and assigns.
7. **Right to Refuse Service:** DCA reserves the right to refuse coaching to any individual, team, or organization under extreme circumstances.
8. **Liability:** DCA is not responsible for any injuries, accidents, loss, or damage to property during sessions.
9. **Session Duration:** Each training session will last approximately 2 hours, subject to facility availability and the age of the participants.
10. **Code of Conduct:** All participants and parents must adhere to DCA's code of conduct. Failure to comply may result in expulsion from the academy without refund.
11. **Equipment:** Participants are responsible for bringing appropriate footwear and cricket equipment. DCA may provide equipment for purchase if needed.
12. **Group Placement:** Participants will be placed in appropriate groups based on age, ability, and session availability.
13. **Payment Terms:** All payments must be made in full in advance through direct debit, cheque, or bank transfer to DCA.
14. **Course Bookings:** Bookings must be accompanied by payment of the relevant course fee. No refunds will be provided for missed sessions.
15. **Course Changes:** Courses, activities, and venues are subject to change due to weather, programming needs, or participant numbers. DCA reserves the right to cancel or change courses, offering alternatives or refunds as necessary.
16. **Fitness and Health:** Parents must ensure that participants are physically fit and able to participate in sporting activities. Medical conditions must be disclosed to DCA prior to the commencement of any course.
17. **Medical Treatment:** In the event of a medical emergency, DCA will arrange for appropriate treatment unless a written notice stating otherwise is provided by the parent or guardian.
18. **Behavior Policy:** DCA prioritizes the safety and wellbeing of all participants. Any participant displaying bullying or disruptive behavior will be removed from the course without refund.
19. **Enrollment Limits:** Enrollment is on a first-come, first-served basis. If a course is full, applicants may be placed on a waiting list or offered a spot in a future session.
20. **Parent Participation:** Parents and guardians are encouraged to support but not interfere with sessions. Disruptive behavior from parents may result in removal from the vicinity.
21. **Media Consent:** By enrolling, you grant DCA permission to use photographs and videos of participants for promotional purposes.
22. **Confidentiality:** Participants and parents agree not to disclose or use any aspect of DCA courses for commercial purposes.
23. **Recording Policy:** Participants and parents are not allowed to record sessions. Still photographs may be taken at designated times for personal use only.
24. **Compliance:** Access to and use of DCA facilities must comply with local laws, school regulations, and academy policies.
25. **Entire Agreement:** These terms and conditions constitute the entire agreement between DCA and the participant, superseding all previous agreements.
26. **Waiver:** Any waiver of these terms must be in writing and signed by DCA. Failure to enforce any provision does not constitute a waiver of that provision.

27. **Severability:** If any term is deemed illegal, invalid, or unenforceable, the remaining terms will remain in effect.
28. **Governing Law:** These terms are governed by the laws of Abu Dhabi, UAE, and any disputes will be settled in the courts of Abu Dhabi.
29. **Training Fees:** Training fees cover only the training sessions at designated centers. Additional costs for activities such as transport, equipment, tours, or personal training will be charged separately.
30. **Class Limits:** If any month exceeds 8 classes, additional charges will apply.
31. **Transport:** Participants should be ready at the pickup location 10 minutes in advance to avoid delays. Training, match timings, and transport schedules may change with short notice.
32. **Nutrition:** Participants should eat at least one hour before training/matches and carry water. Junk foods and fizzy beverages are not allowed.
33. **Team Selection:** DCA does not guarantee selection in teams or matches. Decisions are made in the best interest of the team, and undue pressure or influence will not be tolerated.
34. **Progress Discussions:** Parents are welcome to discuss their child's progress with management but must refrain from interference or negative comments during sessions.
35. **Quality Audits:** DCA conducts regular quality audits involving trainee and parent feedback. Honest feedback is encouraged for continuous improvement.
36. **Re-registration:** Participants who discontinue for more than 3 months must re-register and pay applicable fees.
